If a computer printout is being provided, all appropriate computer codes that identify medical payments should be identified. You may mark the relevant entries on the list with some distinguishing mark. If the request covers dates of service that extend beyond the allowable reimbursement period, the dates of service and corresponding amounts that fall within the allowable reimbursement period must be designated. For dates of service which precede the request for supersedeas but are after the judge's termination date, you must include proof that the bill for treatment was submitted and paid after supersedeas was requested and denied.

To respond to this letter, proceed to the SFR Application tab on the Claims Summary screen. Click on the hyperlink for the "Pending Rejection" application, navigate to the "Documents and Correspondence" tab, and choose to:

- "Continue Review" requires a written response, provides the opportunity to upload missing documentation, and places the application back "In Review" to be processed.
- "Withdraw" Withdraws the application with no further action from the Bureau. If you need a record of your withdrawal, please be sure to print out the confirmation message displayed in WCAIS. No additional letter will be sent; however, your
