Filing Requirements	Submission requirements shall be as follows: <ol style="list-style-type: none"> 1. One copy of the completed Boiler Industrial Board Petition (LIIB-303). <ul style="list-style-type: none"> • A separate request must be submitted for each boiler installation requiring a variance. 2. One copy of the completed Intent to Install Boiler (LIBI-320) for each unit, or a copy of the approved intent to Install Boiler Application for the boiler you are requesting variance for. 3. If moving a boiler, one copy of the completed Permit to Move Boiler or Unfired Pressure Vessel (LIBI-301) and a copy of the Manufacturer's Data Report for each unit being moved. 4. Three sets of boiler or mechanical room plans on paper not less than 18" x 24", drawn to a scale of a minimum 1/4" = 1' - 0", including the following: <ul style="list-style-type: none"> • Floor plan of boiler or mechanical room showing all equipment and objects. • Elevation of boiler or mechanical room showing the location of the reduced overhead clearance if a variance from the 72" overhead clearance is requested. • Dimensions of all equipment clearances. Clearances are measured from the boiler or from any pipe appendage extending beyond the boiler. 5.
