Definitions:

FROI- We have received a FROI.

Temporary- Insurer has 90 days to decide whether to accept or stop and deny the claim. If no action is taken, the claim will automatically convert to either Medical Only or Compensable.

Medical Only- Insurer is accepting liability for Medical payments.

Compensable- Insurer is accepting liability for Indemnity and Medical payments.

Comp Denied- Insurer has denied the claim.

Suspended- Indemnity has been suspended but Medical payments remain.

Closed- All payments on the claim have terminated.

Suspended- ACSR- Claim was suspended through the Annual Claims Status Report.

No FROI- A petition, Med Fee, Utilization Review, or IRE has been received when no previous claim existed. Please use the JCN on your FROI 00.
