

2022 Clean Energy Workforce Development Grant Awardees

The PA Department of Labor & Industry (L&I) granted \$2,000,000 in funding for the Clean Energy Workforce Development Grant (Clean Energy Grant) that aims to ensure that businesses and job seekers remain competitive in this sector over the next decade through increased connections to local partners and training opportunities, deployment of work-based training models and upskilling methods, and expanded access to career pathway development in the industry.
