Approval of June 10th Meeting Minutes

- Gregory Chambers noticed a typo in his name under the New Business section.
- Motion to approve June 15th minutes with administrative changes submitted by Robert Bair; seconded by Mike McGraw. Motion approved unanimously.

Ex-Officio Member Report: Office of Vocational Rehabilitation, PA Department of Labor and Industry (Jeffrey Seabury, Vocational Rehabilitation Specialist)

His office is continuing to engage several employers around apprenticeship and pre apprenticeship.

They also now have their 6th and 7th employees involved in the Navigator Apprenticeship program.

Ex-Officio Member Report: Unemployment Compensation Program, PA Department of Labor and Industry (Maria Macus, Deputy Secretary)

• June 2023 the unemployment rate was 3.8 percent and there were 246,000 individuals that were unemployed. The week ending August 5th had 11,047 regular initial unemployment claims. The average wait time on their phones is down to 30 minutes and the average wait time for chat is 32 seconds.

Ex-Officio Member Report: Workforce Development, PA Department of Labor and Industry (Daniel Kuba, Deputy Secretary)

- In July, Secretary Walker and Deputy Secretary Daniel Kuba were able to meet with Governor Shapiro. Specifically discussing apprenticeship and pre apprenticeship. They are currently working to make sure that they are continuing to work towards Governor Shapiros goal in support of the apprenticeship model as well as pre apprenticeships. He stated that they are committed to new sector apprenticeships and are trying to identify occupations that will fit into that apprenticeship model. One of the current projects being worked on are teacher apprenticeships. They are still working on bringing someone in to build a template for the teacher apprenticeship model.
- The one major issue across the workforce is childcare. They are using other programs already in the state infrastructure, such as 1199C, to help build and shape future childcare programs.
- They have the Strategic Early Morning Network (SEMN) based out of Pittsburgh under contract. The network supports employers who are in a delicate state, and they also helped bring companies back into Pennsylvania.
- Because of positive budget changes the grants should be able to be processed for up to 2-3 years or the time that is appointed
 by the grant availabilities. They are continuing to work to put this process in motion. Another positive outcome of the budget
 change is School to Work. School to Work is a 3.5-million-dollar allocation that primarily supports pre-apprenticeship
 programs.
- They put out the 4th round of the Digital Literacy Grant. Digital literacy impacts about 85 percent of Pennsylvanians that visit CareerLink's. This grant allows these Pennsylvanians to learn new skills and utilize them while applying for future jobs.
- A round of Diversity Equity Inclusion Accessibility (DEIA) grants went out. They submitted four projects for about 550,000 dollars that will expand diversity and equity in the Commonwealth.

 - Sponsor representative gave an overview of changes that were made from the list council suggested last meeting
 - A discussion took place between the sponsor and council.
 - Robert Bair made a motion to approve the program as submitted; was seconded by Mike McGraw; motion was carried unanimously by council; no abstention.

Initial "Review of Standards of Apprenticeship" and Trade/Occupation additions

- a) ABC of Western PA, Heating & Air Conditioning Mechanic & Installer, 1st Review, Trade Program, Group Non-Joint
 - Sponsor Representative: Matthew Waltman, Director of Education & Workforce Development, ABC of Western PA
 - Sponsor representative shared an overview of the program.
 - A discussion took place between the sponsor and council.
 - Summary of changes council suggested:
 - Appendix A-2 Safety add fall protection, ladder safety, personal protective equipment, lock out tag out, first aid, confined space, dehydration, EPA universal certified.
 - o Include statistics on the last 10 years of performance.
 - Suggestion to check medical Marijuana and how it related to the law.
 - Mike McGraw made a motion to consider this program at the next council meeting; was seconded by Robert Bair; motion was carried unanimously by council; no abstention.

b) Congreso de Latinos Unidos, Peer Specialist, 1st Review, New Program, Group Non-Joint

- Sponsor Representative: Caroline Haeffner, Training and Post-Secondary Education Manger, Congreso de Latinos Unidos
 - Sponsor representative gave an overview of changes that were made from the list that council suggested last meeting.
- A discussion took place between the sponsor and council.
- Summary of changes council suggested:
 - Clarifying which RTI providers are delivering the content vs awarding college credit.
 - Need to clarify RTI & if it is truly frontloaded for the credential or not.
 - o Verbiage surrounding "as capacity allows". Remove this and provide more supportive/definitive language.
 - o Standards and employer agreements should not contradict each other.
 - o Include language that explains the potential for casework to be done in the field and in the office.
 - Outline career ladder/upward mobility opportunities that stem from Peer Specialist role.
 - Include mention of transportation costs As required for their job & reimbursements.
 - OSHA statement that applies to office-based work hazards.
- Barry Kindt made a motion to consider this program at the next council meeting; was seconded by Robert Bair; motion was carried unanimously by council; no abstention.

c) CybXSecurity LLC, Cybersecurity Support Technician, 1st Review, New Program, Individual Non-Join

- Sponsor Representative: Tom Pedder, Chief Operating Officer, CybXSecurity LLC
 - Sponsor representative shared an overview of the program.
- A discussion took place between the sponsor and council.
- Summary of changes council suggested:
 - o Competency needs to be standardized so it is the same for everyone and needs to be clearer.
 - Clarify the RTI and OJT hours.
 - List the minimum requirements to be a journeyworker.
- Robert Bair made a motion to consider this program at the next council meeting; was seconded by Gregory Chambers;
 motion was carried unanimously by council; no abstention.

d) Celerity Integrated Services, Line Installer/Repairer, 1st Review, New Program, Individual Non-Joint

- Sponsor Representative: Deron Leight, Vice President, Celerity Integrated Services
 - Sponsor representative gave an overview of changes that were made from the list that council suggested last meeting.
- A discussion took place between the sponsor and council.
- Summary of changes council suggested:
 - Tie WPS/OJT/RTI to a verifiable 3rd party.
 - o Call out specifically what safety items are being taught and practiced.
 - Specific mentions of Bucket Safety, Rigging, Competent Climber.
 - Expand more on transferrable credentials.
 - Clean up the Journeyworker section of Appendix D. Confusing language surrounding the progressions.
 - What certificates will the apprentice get and who verifies it.
- Barry Kindt made a motion to consider this program at the next council meeting; was seconded by Mike McGraw; motion was carried unanimously by council; no abstention.

- Summary of changes council suggested:
 - Add the OSHA classes being provided.
 - o Add clear distinction of journeyworker criteria.
 - Add the national standards for a journeyworker including the upward mobility, career pathways.

Report: PA Apprenticeship and Training Office, PA Department of Labor and Industry

- Cristie DeWitt, Field Apprenticeship and Training Representative Supervisor
 - She advised council that Danielle Demirovic was promoted to Pre-Apprenticeship Supervisor, and they are looking to expand her division with new staff.
 - Crisite DeWitt and Director Tara Loews' divisions have had staffing changes.
 - Allie Harris was hired as a Clerical Assistant 2.
 - Theodore Warholic was hired as a Northern Apprenticeship and Training Representative.
 - In September they will start interviews for a Special Projects ATR.
 - o November 13th -17th will begin National Apprenticeship Week.
 - A promotional tool kit will go out to sponsors with need-to-know information for marketing events.
 - The ATO Office is going to partner with PWDA as a platinum sponsor for an Apprenticeship summit that will be held on November 13th and 14th at the Hershey Lodge.
- Sam Primak, Grants, Compliance and Statistical Development Supervisor
 - They finished evaluations for Increasing Diversity, Equity, and Inclusion Grant initiative and they hope to announce the awards soon.
 - The Creating Nursing Pathways in PA and Supporting Broadband Infrastructure Grants are still under review.
 - They are seeking proposals for building and supporting a certified teacher registered apprenticeship program and the deadline for applications is September 15th at 4pm.
 - A 1.2-million-dollar state apprenticeship expansion formula grant was received in June from the United States
 Department of Labor. With this funding they plan to strengthen their roll within the PA apprenticeship ecosystem.
 - There is a position posted for a Grants, Statistical Development, and Special Projects Specialist. The posting closes on August 13th.
- Gregory Chambers asked where the funding from the Biden administration was going.
 - Deputy Secretary Daniel Kuba responded by saying Pittsburgh is one of the 5 workforce Hubs that was chosen for funding. These investments are from the government and private investors. He also stated that once he receives an updated report, he will advise council.
