

Final Report of the IBC general subcommittee for the UCC RAC 2015 re-review

The IBC general subcommittee reviewed 281 sections of the 2012 and 2015 IBC for acceptance in Pennsylvania. No changes were judged necessary to that spreadsheet and the subcommittee voted to support all of the changes which did not receive a public comment. The subcommittee was assigned nineteen public comments which were reviewed and had the following outcomes.

Of the 19 public comments received 11 were to adopt Appendix G (Flood Resistant Construction). This left 4 public comments subject to review. Two were moved to more appropriate committees; leaving 2 public comments for review. The results of the review and vote on these sections are shown highlighted above. Adoption of appendices is currently under review by Counsel. Therefore these sections were not voted on at this time.

I move the 2015 IBC general sections which did not receive a Public Comment be adopted for inclusion in the Pennsylvania Uniform Construction Code excluding any section modified by legislative amendments.
