## Final Report of the IRC general subcommittee for the UCC RAC 2015 re-review

The IRC general subcommittee reviewed 404 sections of the 2012 and 2015 IRC for acceptance in Pennsylvania. No changes were judged necessary to that spreadsheet and the subcommittee voted to support all of the changes which did not receive a public comment. The subcommittee was assigned twenty seven public comments and one RAC comment which were reviewed and had the following outcomes.

Of the 27 public comments received 5 were in support of adoption of various sections. 3 were to retain a legislative amendment. 7 were to adopt Appendix F (Radon Control Requirements). In addition, the subcommittee received a request to adopt NFPA 750 (Mist Fire Sprinkler Code). This left 11 public comments subject to review. The results of the review and vote on these sections are shown highlighted above. We also received a request to adopt Appendix U from the Chair. Adoption of appendices is currently under review by Counsel. Therefore these sections were not voted on at this time.

I move the 2015 IRC general sections which did not receive a Public Comment be adopted for inclusion in the Pennsylvania Uniform Construction Code excluding any section modified by legislative amendments.
